



Leading Through Innovation: Technology That Enables Healing

TELEHEALTH APPOINTMENTS: ACCESS TO CARE WHEREVER YOU ARE

We offer convenient, safe access to healthcare services via computer or mobile device. Many of our physicians offer **telehealth appointments**, and for immediate needs, Covenant Health offers **virtual urgent care** with emergency-trained providers who are available 24/7 anywhere in East Tennessee.



VIRTUAL CARE AT OUR HOSPITALS

Virtual services at our hospitals offer advanced care for complex medical conditions and help smaller communities through remote access to specialized Covenant Health resources. Our physicians use telehealth technology to remotely monitor patients' conditions or consult with other medical specialists. Covenant Health was the first organization to implement **tele-ICU** as an extra layer of care for critical care patients at our hospitals. Virtual technology is also used in areas such as neurology and cardiology, and for remote psychiatric evaluations.



ADVANCED CARE AT HOME: HOSPITAL-LEVEL CARE IN THE COMFORT OF HOME

In 2023 Covenant Health was the first healthcare organization in the area to launch Advanced Care at Home, a unique program that allows patients to receive around-the-clock medical care and remote monitoring in their own homes.



With Advanced Care at Home, patients are monitored around the clock by a team at a virtual care operations center and can communicate with a provider at any time. A mobile health team visits the patient's home twice daily, and nurse practitioners or physician assistants make in-home visits. Other healthcare professionals such as physical therapists may also provide care.

Advanced Care at Home serves eligible patients with specific conditions like heart failure, COPD, and gastroenteritis, among others. The hospital-level support includes medication management, laboratory services, intravenous (IV) infusion services, rehabilitation therapies, oxygen treatments, X-ray and ultrasound, all provided in the home.

This care model has been shown to increase patient satisfaction, improve outcomes, reduce ER readmissions, and shorten hospital stays.

"This is an innovative step in transforming the future of healthcare delivery" said Mandy Grubb Halford, MD, Senior Vice President, Chief Medical Officer and Chief Medical Informatics Office for Covenant Health. "Advanced Care at Home is another 'first' in bringing virtual technology and dedicated medical professionals together to better serve our patients and communities."

In 2023, **\$4,259,000** in donations were distributed to support these initiatives:

- Medical care and monitoring for patients in Covenant Health's onsite clinic at Knox Area Rescue Ministries (KARM)
- Nurse navigators to guide cancer patients through treatment

 - 30-day supplies of critical medications for Peninsula Behavioral Health patients at discharge
 - Free screening mammograms for women in need
 - Purchase of patient care equipment
 - Support for clinical trials

Building for the Future: Training Tomorrow's Healthcare Professionals

Covenant Health is preparing future healthcare professionals through many education initiatives:

- Covenant Health partners with postsecondary schools throughout our region, involving 1,000+ students from 20+ schools.
- A land donation from Covenant Health provided a site across from Parkwest Medical Center for a new Knoxville Healthcare Training and Simulation Center for Roane State Community College and Tennessee College of Applied Technology.
- Programs at several Covenant Health hospitals train and pay high school students to work in support roles in preparation for future healthcare studies.
- Clinical training rotations give advanced medical students at Lincoln Memorial University's DeBusk College of Osteopathic Medicine a chance to experience a variety of specialties.
- Residency programs for healthcare graduates include postgraduate training for pharmacists, a nurse residency program for new nursing graduates, and a new Family Medicine Residency program.

NEW RESIDENCY PROGRAM HELPS MEET GROWING NEED FOR FAMILY DOCTORS

In 2023, Covenant Health's Methodist Medical Center announced a new program that brings medical school graduates to the Knoxville-Oak Ridge area to continue their advanced training to become family doctors. The Methodist Family Medicine Residency Program is accredited by the American College of Graduate Medical Education (ACGME).

The residency program is integrated with the newly opened Methodist Family Medicine Clinic in Oak Ridge. Residents are guided by physicians and administrators as they provide care and participate in special projects.

"We are creating a top-quality program that produces well-trained family medicine physicians," said program director James Schindler, MD, MPH. "Residents will have the resources of Methodist Medical Center and Covenant Health, plus the amazing community of Oak Ridge, and all the latest technology and training tools at their disposal."



Research Provides Resources for Better Care

CLINICAL TRIALS BRING HOPE TO PATIENTS



Patients at Covenant Health's Thompson Cancer Survival Center get more than great cancer care. They benefit from groundbreaking research by a team of oncology professionals that is like no other in the region.

Thirty years after its beginnings, Covenant Health's Thompson Cancer Survival Center remains a leader in pivotal clinical research. Research helps answer important questions, and those answers can lay the groundwork for preserving quality of life or even saving lives.

"For instance, our participation in key melanoma trials has paved the way for successful melanoma treatments used today," says oncologist David Chism, MD, Thompson's director of clinical research. "The results of those early trials are evident in higher survival rates for today's melanoma patients."

Thompson has nearly 25 active oncology trials. The research is so impactful that Thompson's clinical trials team has been chosen to deliver findings before national organizations.

According to the American Society of Clinical Oncology, only about three percent of cancer patients participate in clinical trials. Dr. Chism would like research to help more current and future patients.

"Our hope is to offer better choices for these patients through clinical trial participation at home, here in Knoxville, where their family and friends can be beacons of support," Dr. Chism says, noting that the level of care meets the high standards set by Thompson for every patient "With increased participation, more therapies and possible cures can reach those affected faster. Time matters."

Covenant Health also has been named the health partner for Morristown Landing, a community recreation, fitness and event center near Morristown-Hamblen South that serves the entire Morristown area. The 115,000-square-foot center includes facilities for sports, aquatics, group fitness and health education classes, programs for children, youth and seniors, and more.

In 2024, Covenant Health opened Covenant Health Therapy Center – Morristown, adding physical rehabilitation services to the offerings at Morristown Landing.

Between its opening in mid-October 2023 and mid-December 2023, Covenant Health Urgent Care visits were as high as nearly 50 visits per day during the Center's extended hours. Covenant Health South also offers medical specialties such as cardiopulmonary rehabilitation, cardiology, nephrology (kidney care) pregnancy care and women's health, and primary care.

FORT LOUDOUN MEDICAL CENTER BREAKS GROUND FOR EXPANSION



In late 2023, Covenant Health's Fort Loudoun Medical Center broke ground for an expansion of the 50-bed medical facility in Loudon County. In part as a result of a donation from The Brethen Foundation, the medical center is constructing a new critical care area called The Brethen Foundation Advanced Care Wing. The expansion will create 26 new patient rooms for both intensive and intermediate care.

A groundbreaking ceremony took place Nov. 3, 2023, with more than 100 community leaders and local officials in attendance, including the Brethen family, whose generous donation helped make the expansion possible.

The 18,000-square-foot addition also will include a nurses' station and family waiting area, as well as an expansion of current emergency department space. The new intensive care unit and expanded emergency department are expected to open in early 2026.






Total Assets




Total Operating Revenue
